

TERMS & CONDITIONS

Here is the 'small print' section of our website: the language may seem formal, but it's not unfriendly, it's just to help us navigate the seas of commerce together. Here's to calm weather and easy voyages!

RETURNS POLICY

- Our policy lasts 14 days. If 14 days have gone by since your purchase, unfortunately we can't offer you a refund.
- To be eligible for a return, your item must be unused and in the same condition that you received it. It must also be in the original packaging.
- Under the Consumer Contracts Regulations, if you change your mind about a purchase you have made within 7 working days after the date of delivery, you are entitled to a full refund of the original purchase price for the goods or services you wish to return, and the original postage and packaging charges made. You will not be entitled to a refund of the cost you incur in returning the item to us.
- Our standard returns policy entitles you to a full refund of the purchase price and postage and packaging charges if you change your mind (i.e. the goods or services provided are not faulty or were not described properly) within 7 working days.

Refunds (if applicable)

- Once your return is received and inspected, we will send you an email to notify you that we have received your returned item. We will also notify you of the approval or rejection of your refund.
- The 50% deposit paid for commissioned items is to cover outlay for materials and design creation: it is non-refundable. If a commissioned item is returned within 14 days, for reasons other than damage in transit, a 50% refund will be applied.
- If you are approved, then your refund will be processed, and a credit will automatically be applied to your credit card or original method of payment, within a certain amount of days.

Sale items (if applicable)

- Only regular priced items may be refunded, unfortunately sale items cannot be refunded.

Exchanges (if applicable)

- We only replace items if they are defective or damaged. If you need to exchange it for the same item, send us an email at bron@bronjonesart.com and send your item to: Penrhiw Farm, Golden Grove, Carmarthen, SA328NE, United Kingdom.

Shipping

- You will be responsible for paying for your own shipping costs for returning your item. Shipping costs are non-refundable. If you receive a refund, the cost of return shipping will be deducted from your refund.
- Depending on where you live, the time it may take for your exchanged product to reach you, may vary.
- If you are shipping an item you should consider using a trackable shipping service, retain proof of postage, or purchasing shipping insurance. We don't guarantee that we will receive your returned item.

SECTION 1 - WHAT DO WE DO WITH YOUR INFORMATION?

SECTION 4 – emediahosting.co.uk

Payment:
